



## **Camp: The Remix FAQs**

### **What type of technology will I need for my camper to participate in the online community?**

Two different online platforms will be utilized; the [Band App](#) and [Zoom](#). Both platforms can be used via phone, tablet, and desktop computer. User access to Band requires a phone number or email address. You will need internet access or cell service. To participate in video Zoom calls, a video camera is needed.

### **Can my camper participate if they don't have access to internet or an electronic device?**

Yes! Your camper can complete all the activities in the box without interacting with the online platforms and while we encourage participation, it is not mandatory.

### **What's in my box?**

Inside you will find curated activities, materials, and limited-edition camp swag! We assume you have the following items (not included in the box): scissors, pencil, pen, ruler, some type of adhesive (glue or tape or glue stick), mark making tools (crayons or markers or color pencils).

### **When will my box arrive?**

Your camper box(es) will be shipped via USPS to the address you provide during registration, 1 week prior to the start of camp. Boxes should arrive 2-3 days before the start of the camp session.

**What if my camper cannot attend a livestream or follow the daily camp schedule?**

Livestream videos are saved and posted in the Band App. All livestreams & how-to videos will be accessible for the entire camp week.

**What about my camper’s privacy and online safety?**

Each week of camp will have its own Band Group. This is a private group and is invite-only. A QR code is included in the box and parents/guardians will receive as a link emailed the week before a session to access the group. Zoom calls are private and access information is shared in the Band Group. Photos, videos, and comments posted will not be shared. Online Community guidelines are in place for all campers as well as online participation waivers.

**Will my camper chat with people they don’t know?**

Campers will “interact” with other campers in their age group via Zoom calls and on the Band App. Livestreams and Zoom calls are supervised by camp staff. Posts, photos, and videos go through an approval process before being seen by the group.

**How will I know what my camper is doing or should to be doing?**

Parents will join our Parent Band Group to see schedule of the weeks’ events, activity prompts, videos, and livestream events.

**Will I have to actively supervise and be present throughout the sessions?**

Depending on your campers’ age and abilities they may need assistance with activities. The goal is for your camper to complete activities on their own and at their own pace. They may need help collecting supplies, accessing the Band App for the first time, or troubleshooting technology.

**How much “screen time” will my camper have each day?**

Our team is working hard to limit screen time to 90 minutes a day. We aim to make this program a blend of online and offline opportunities.

**Do I need to be a registered Girl Scout to attend?**

No, you do not need to be a registered Girl Scout to participate. However, you need to be within the age range and be a girl or identify as a girl. No tagalongs please.
