Rules of Order for the 2<mark>020 Annual Meeting</mark>

1. *Members:* All registered members shall sign in before entering the virtual meeting room. Only those who registered as a Girl Scout member by April 14, 2020 may attend the annual meeting.

2. Voting:

A. An online voting application will be available for each eligible voting member to use for voting on the election.

B. There shall be no proxy or absentee voting.

3. *Quorum:* The quorum for the annual meeting shall be the registered attendance of a minimum of 200 members representing 25% or more of the council's service units.

4. *Electronic Personal Devices:* Mobile phones, tablets, and pagers shall be placed in silent or vibrate mode during the meeting. Video cameras and recording devices shall not be used during the meeting.

5. *Minutes:* The minutes of the annual meeting will be placed on the GSGLA website, girlscoutsla.org.
